

**ADMINISTERING THE TUITION WAIVER  
REQUEST FORM**

The tuition waiver program is available to all full-time employees of Northeast. Any adjunct faculty, Sudexho employees and part-time staff personnel are not eligible for the tuition waiver. Any qualified person wishing to apply for the tuition waiver must complete a Tuition Waiver Request form in the student Financial Aid office.

A dependent child is defined the same as a dependent student applying for federal student aid. **THE DEPENDENT CHILD MUST ANSWER ‘NO’ TO ALL QUESTIONS LISTED BELOW.**

1. Were you born before January 1, 1997?
2. Will you be working on a degree beyond a bachelor’s degree in school year 2020-2021
3. As of today, are you married? (Answer yes if you are separated, but not divorced.)
4. Answer “YES” if (1) You have children who receive more than half of their support from you; or (2) You have dependents (other than your children or spouse) who live with you and receive more than ½ of their support from you, now and through June 30, 2021.
5. Are you an orphan or ward of the court or were you a ward of the court until age 18?
6. Are you a veteran of the U.S. Armed Forces?

**IF A STUDENT ANSWERS ANY QUESTION “YES,” THE STUDENT IS NOT ELIGIBLE FOR A TUITION WAIVER.**

A spouse is defined as a person whom the full-time employee is legally married and resides in the same household. If the employee is divorced or separated, the spouse is not eligible for the tuition waiver.
